Effective October 1, 2006, AquaSource Utility, Inc. (AquaSource) merged with Aqua Utilities Florida, Inc. (Aqua Utilities FL), with Aqua Utilities FL the surviving corporation. Both AquaSource and Aqua Utilities FL are wholly owned by Aqua America, Inc. (Aqua America). The purpose of the merger was to consolidate all of Aqua America's Commission-regulated water and wastewater assets in Florida under one corporation separate from its non-Commission regulated assets. Attached are charts showing the organizational structure before and after the consolidation.

Section 2.07(C)(2)(a) of the Administrative Procedures Manual grants staff the authority to approve changes of names and corporate reorganizations where no change of ownership or control or transfer of assets is involved. Since Aqua America continued to own and control the utility assets after the merger, staff administratively acknowledged the reorganization and approved the name change by Order No. PSC-06-0973-FOF-WS, issued November 21, 2006, in Docket No. 060643-WS.




FLORIDA CONSOLIDATION LEGAL ENTITIES - "BEFORE"
