On behalf of BellSouth Long Distance, Inc. ("BSLD"), I am pleased to inform you that the merger between AT&T Inc. and BellSouth Corporation closed on December 29, 2006, at which time BellSouth Corporation became a whollyowned, first-tier subsidiary of AT&T Inc.

As a result of the merger at the holding company level, BSLD will adopt the AT&T brand name for its products and services. The transition from the use of the BellSouth brand name to the AT&T brand name is expected to occur over the next few months.

To that end, BSLD hereby respectfully requests that the Florida Public Service Commission ("Commission") approve an amendment to BSLD's certificate (CLEC Certificate No. 5261 and IXC Registration No. TI554) to include the doing business as ("d/b/a") name "AT&T Long Distance Service." While BSLD will remain a corporate entity certificated in this State, with this Commission's approval, BSLD will do business under the d/b/a name of "AT&T Long Distance Service." This request does not involve the transfer of any certificates.
