TREVISO BAY DEVELOPMENT, LLC'S UNOPPOSED MOTION
FOR EXTENSION OF TIME TO FILE TESTIMONY

Treviso Bay Development, LLC ("Treviso Bay"), pursuant to Rule 28-106.204, Florida Administrative Code, and by and through its undersigned counsel, hereby moves the Commission, through the Prehearing Officer designated for this docket, to issue an order modifying the procedural schedule set forth in Commission Order No. PSC-06-1076-PCO-TL, as follows:

1. Changing the date for Treviso Bay to file its testimony and exhibits from January 17 to January 24, 2007;
2. Changing the date for filing prehearing statements from January 19 to January 24, 2007;
3. Changing the date of the Prehearing Conference to a date later than January 24 that is convenient for the Prehearing Officer; and
4. Changing the date for the PSC Staff to file their testimony and exhibits, if any, from January 24 to January 31, 2007.

Treviso Bay believes that the other dates set forth in Order No. PSC-06-1076-PCO-TL can remain the same. If the date of the Prehearing Conference cannot be changed to a later date,
