**PROGRESS ENERGY FLORIDA, INC.'S
NOTICE OF FILING IDENTIFICATION OF ISSUES**

Progress Energy Florida ("PEF" or the "Company"), pursuant to the Time Schedule (CASR) established for this docket, hereby submits its Notice of Filing Identification of Issues. The Crystal River Unit 3 Uprate project ("CR3 Uprate project") is an innovative project which, by taking advantage of technological advancements and efficiencies, will result in an increase of approximately 180 megawatts of nuclear generation at PEF's CR3 unit. The CR3 Uprate project will be completed in two phases, during the planned 2009 and 2011 refueling outages. PEF identifies the following issues for appropriate resolution and consideration in the above docket:

1. Were the costs of PEF's CR3 Uprate project anticipated or addressed in PEF's latest base rate proceeding?
2. Will PEF's CR3 Uprate project result in fuel savings that exceed the costs of the CR3 Uprate project?
3. Is PEF's CR3 Uprate project an innovative project which will result in lower costs to customers?
4. Based on the resolution of these foregoing issues, should PEF be permitted to recover its costs for the CR3 Uprate project through the fuel clause?


