## NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING CERTIFICATE TO PROVIDE PAY TELEPHONE SERVICES

#### BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

D.C. TeleSystems, LLC (TeleSystems) has applied for a certificate to provide Pay Telephone (PATS) services pursuant to Section 364.3375, Florida Statutes. Upon review of its application, it appears to be in the public interest to grant to TeleSystems Certificate No. 8673.

If this Order becomes final and effective, it shall serve as TeleSystems' certificate. TeleSystems should, therefore, retain this Order as proof of certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.3375, Florida Statutes.

PATS providers are subject to Chapter 25-24, Florida Administrative Code, Part XI, Rules Governing Pay Telephone Service Provided by Other Than Local Exchange Telephone Companies. PATS providers are also required to comply with all applicable provisions of Chapter 364, Florida Statutes, and Chapter 25-4, Florida Administrative Code.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year. A RAFs Return notice will be mailed each December to TeleSystems for payment by January 30th. Neither the cancellation of the certificate nor the failure to receive a RAFs Return notice shall relieve TeleSystems from its obligation to pay RAFs.
