Dear Ms. Bayo:

070175-TP Attached please find the original and three (3) copies of the Petition for Authority to Transfer Assets submitted on behalf of Access Integrated Networks, Inc. ("AIN") in connection with a partial customer base transfer from IDT America, Corp. ("IDT") to AIN. The Parties hereby notify the Commission of their entry into an agreement whereby AIN will acquire certain presubscribed customers in Florida from IDT.

Affected customers will not experience any other changes with respect to their current regulated services and only a minor change to their non-regulated voice mail service. The proposed transfer will affect approximately 5,000 presubscribed customers in the State of Florida. The date for the customer transfer is scheduled to begin on or after April 25, 2007 based on Commission approval. Once the transaction is consummated, AIN will provide local and/or long distance service to these customers.

If a former IDT customer were to file an inquiry after the transfer, the Commission staff should contact me here at AIN as the current carrier, preferably with a copy to IDT. I would then work with Anthony Acevedo who is the IDT contact for regulatory inquiries, to resolve the issue if it involves the period prior to the customer's being transferred. I will handle coordination and response with the Commission staff. Mr. Acevedo and I have established the process we plan to use to handle such occurrences. Because we are the sole personnel involved, and because we have jointly established the procedure, both companies believe that customers' concerns will be promptly and thoroughly resolved, with no issues as to who is responsible.

Customers affected by this change were notified by letters mailed beginning March 14, 2007. A copy of the Parties' FCC filing and customer notification are attached. Customers have been provided TATE

least thirty days' notice of the pending change. The customer notification advises customers of the following: (1) the pending change of their service provider to AIN; (2) there will be no charges associated with their change to AIN as their local and/or long distance provider; (3) only their non-regulated voicemail service will be affected and will be provided at the same rates as those currently charged by IDT; (4) they have the option to select a different service provider if they prefer. The notification also includes customer service numbers for both IDT and AIN that customers may call for more information.

JOINT PETITION FOR WAIVER

Pursuant to Rule 25-24.455(4), IDT America, Corp. ("IDT" or "Seller") and Access Integrated Networks, Inc. ("AIN" or "Buyer") (together, "Petitioners") respectfully request that the Florida Public Service Commission ("Commission") waive Florida Administrative Code rule 25-24.118, in order to facilitate the transfer of customers from IDT to AIN, both certificated telecommunications carriers in the state of Florida.

Upon approval of this waiver request, IDT seeks to transfer approximately 5,000 presubscribed residential customers in Florida to AIN. On or about March 12, 2007, the parties sent a notification to all affected customers. This notification advised the customers of the following: the pending change of their carrier selection to AIN; that there will be no change to the rates, terms, and conditions of the service(s) to be provided by the acquiring carrier; there will be only a minor change in the customer's non-regulated voicemail service; that there will be no charge to the customer in connection with this change; that the subscriber has the right to select a different preferred carrier; toll-free customer service telephone numbers for inquiries about the transfer; the fact that all subscribers receiving the notice, including those who have arranged preferred carrier freezes through their local service providers, will be transferred to the new carrier if they do not select a different preferred carrier before the transfer date; and whether the acquiring carrier will be responsible for resolving outstanding complaints against the selling or transferring carrier. A sample copy of the customer notification is attached to this Petition as Exhibit A.

Petitioners respectfully request that the Commission issue an order granting a wavier of Rule 25-24.118 in order to consummate the transfer of customers. In support of this request, Petitioners provide the following information:

I. THE PETITIONERS and PARTIES

IDT America, Corp. ("IDT") is a local exchange and non-dominant interexchange

telecommunications service provider incorporated under the laws of the State of New Jersey. IDT was granted

authority to provide local exchange telecommunications services in Florida by Order No. PSC-02-1730-CO-

TX issued December 9, 2002 in DN 020974-TX. Interexchange authority was granted pursuant to Order No.

PSC-98-0637-FOF-TI issued May 7, 1998 in DN 980375-TI. IDT is certified, registered or otherwise

authorized to provide local services in forty-five states and long distance services nationwide. IDT seeks to

transfer approximately 5,000 presubscribed residential customers of its services in Florida to AIN.

Access Integrated Networks, Inc. ("AIN"), a Georgia corporation, was granted local exchange

authority in Order No. PSC-99-1491-PAA-TX issued August 3, 1999 in Docket No. 990666-TX. AIN

received interexchange authority pursuant to Order No. PSC-99-1493-PAA-TI issued August 30, 1999 in

Docket No. 990665-TI. AIN's managerial, technical and financial ability to provide telecommunications

services are a matter of record with the Florida Public Service Commission. A copy of AIN's Certificate to

Transact Business as a Foreign Corporation is incorporated herein by reference. AIN is authorized to provide

local and long distance services in nine states.

III. REQUEST FOR RULE WAIVER

Pursuant to Rule 25-24.118(1), Florida Administrative Code, the provider of a customer shall not be changed without the customer's authorization. Rule 25-24.118-(2) provides that a local provider or IXC shall submit a change request to the local exchange carrier only if one of the following has occurred: (a) the provider has a letter of agency from the customer requesting the change; (b) the provider has received a customer-initiated call for service; or (c) a third party firm has verified the customer's requested change. As a result of the proposed transfer agreement described above, the Petitioners ask the Commission to waive the conditions in 25-24.118-(2) in order to allow the transfer of customers of record to AIN. AIN has filed Notice with the Federal Communications Commission for a waiver of the authorization and verification rules for implementation of the subscriber carrier selection change provisions of the Telecommunications Act of 1996.

IV. CUSTOMER IMPACT

This transaction will be handled so as to avoid undue disruption to consumers. There will be only a minor change of the voicemail service and no change or interruption of local or long distance service and customers will be well informed of their choices.

V. PUBLIC INTEREST CONSIDERATIONS

The Petitioners have determined that the proposed transaction will improve operational efficiency of

both companies, thus providing greater opportunities to improve the price performance of services available to

its customers. If prior authorization is required in this event, customers may fail to respond to a request for

authorization, neglect to select another long distance carrier and lose their long distance service during the

transition. Consequently, granting this Petition is consistent with the public interest in promoting competition

among telecommunications carriers in Florida. Further, by granting this Petition, unnecessary slamming

complaints will be prevented during the transition, saving Petitioners and the Commission administrative

burdens.

WHEREFORE, for the reasons stated above, the Petitioners submit that the public interest,

convenience and necessity would be furthered by a grant of this Joint Petition for Waiver of Rule 25-24.118.
