

2 CHAIRMAN EDGAR: And we will begin discussions with
3 Item 11.

4 MR. MAILHOT: Yes, Commissioners.

5 Item 11 is staff's recommendation concerning
6 BellSouth's COLR letter of engagement. Late yesterday the
7 parties filed a very minor modification to the letter that's
8 attached to the recommendation. Staff has reviewed those
9 changes, and we think they are -- we would still recommend that
10 the modified letter be found to be in compliance with
11 Section 364.025 of the Florida Statutes, and the parties are
12 here to answer any questions that you may have about the
13 revised letter.

14 CHAIRMAN EDGAR: Thank you.

15 Mr. Meza.

16 MR. MEZA: Good morning, Madam Chair. Jim Meza on
17 behalf of AT&T Florida. Mr. Buys is correct, we did make some
18 changes in agreement with Lennar yesterday. BellSouth supports
19 staff's recommendation and asks that you approve the
20 agreed-upon changes. Thank you.

21 CHAIRMAN EDGAR: Thank you.

22 Mr. Hatch. No?

23 Ms. Keating.

24 MS. KEATING: Good morning, Madam Chair,
25 Commissioners, Beth Keating, Akerman Senterfitt. I'm here

1 today on behalf of Lennar, and I just want to echo the comments
2 of Mr. Meza. We have agreed to certain changes in the letter,
3 and with those changes, we agree with staff's recommendation.

4 CHAIRMAN EDGAR: Thank you.

5 Commissioners, as you know, this item has been on our
6 agenda previously and the parties worked cooperatively,
7 diligently, I know a lot of conversations to get to this point
8 where we have a consensus recommendation, I think. And so I
9 know I appreciate that cooperative effort.

10 Commissioners, are there questions? Is there a
11 motion?

12 COMMISSIONER CARTER: Move it.

13 COMMISSIONER McMURRIAN: Second.

14 CHAIRMAN EDGAR: Okay. All in favor say aye.

15 (Unanimous affirmative vote.)

16 CHAIRMAN EDGAR: Item 11 is approved with the
17 consensus language in the letter.
