NOTICE OF CUSTOMER MEETINGS

In re: Docket No. 060638-EI
 Petition of Florida Public Utilities Company for approval of an increase to base rates through a limited proceeding to recover costs associated with mandatory storm preparedness initiatives

Pursuant to Section 366.076, Florida Statutes, Florida Public Utilities Company is seeking approval for a revision to its current base rates in order to recover the costs associated with implementing storm preparedness programs required by the Florida Public Service Commission in Docket No. 060198-EI. These programs were not in existence or anticipated when the base rates of the Company were last established, and the significant, unanticipated annual costs of these programs, projected to be \$713,517 in 2007, would have an adverse effect on the financial position of the Company. The relief sought by the Company would enable implementation of the storm hardening initiatives while also maintaining the financial status of the Company. The Company is seeking to recover these expenditures through an adjustment to base rates. The adjustments to the non-demand energy charge component of the base rate are shown below.
