This letter responds to your letter of March 29, 2007, wherein you requested additional information concerning the above-named docket. The Utility's responses to the six items enumerated in your letter are as follows:

1. A schedule of tests along with costs paid to outside laboratories for testing water and wastewater treatment during the test year is attached hereto as Schedule A.

It is the utility's understanding that the costs of testing will not increase in the year 2007. In addition to the tests and costs identified in Schedule A for the test year, the utility will have a Nitrate/Nitrite test that will have to be performed each year, once per year, at a cost of \$85.

- 2. The utility tested for lead and copper in September and in November of 2005 because the first set of tests had too many exceedances.
- 3. Mink Associates II, LLC (Mink II) is the utility, which does business as Crystal Lake Club Utilities. Mink Associates I, LLC (Mink I) is the company which was formed for the sole purpose of owning, operating, and managing the real estate project known as Crystal Lake Club. Mink I and Mink II are related companies, with Arlene Mink being the Managing Member. GDR Management is unrelated to Mink I and Mink II, and is the management company owned by Gerald D. Ross, who is the Manager for both Mink I and Mink II.
- 4. Crystal Lake Club is expected to have 589 lots at build out.

- 5. There are currently 517 occupied lots in Crystal Lake Club.
- 6. All occupied lots are individually metered.
