# AT&T FLORIDA'S REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida"), pursuant to Rule 25-22.006, Florida Administrative Code, and Section 364.183, Florida Statutes, files its Request for Specified Confidential Classification.

- 1. On April 24, 2007, AT&T Florida filed its Responses to Florida Public Service Commission Staff's (hereinafter "Staff") Data Request No. ATT-2. AT&T Florida's Response to Staff's Data Request No. ATT-2, attachment to Item No. 1, contains information that is confidential and proprietary to AT&T Florida. A Notice of Intent to Request Specified Confidential Classification was also filed on the same day.
- 2. Pursuant to Rule 25-22.006, AT&T Florida hereby files this Request for Specified Confidential Classification because the above document contains information considered confidential business information related to the competitive interests of AT&T Florida that is proprietary to AT&T Florida. Therefore, such information should be classified as confidential business information pursuant to Section 364.183, *Florida Statutes*.
