Pursuant to the Notice from the Office of the General Counsel dated May 14, 2007, BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida") and TCG South Florida, Inc. ("TCG") respectfully submit their Comments on the Petition of Tampa Electric Company ("TECO") for Approval of Storm Hardening Plan filed on May 7, 2007 (the "Proposed Plan").
