As you know, our firm represents Level 3 Communications. On July 5, 2007, Petitioner Neutral Tandem filed a Motion for Leave to Amend Petition and a Proposed Amended Petition. In its Motion, Neutral Tandem also suggested that it would be appropriate for the Commission to defer consideration of the legal issues addressed in the Staff Recommendation beyond the July 10, 2007

specifically state that neither Neutral Tandem nor its customers will act as an agent for the other. Neutral Tandem's sudden change on the agency issue is an obvious attempt to salvage its standing which should be summarily rejected by the Commission. Interestingly enough, these new agency letters are specifically limited to the technical and operational aspects of terminating transit traffic through Neutral Tandem - - and do not authorize Neutral Tandem to address intercarrier compensation on behalf of the principals to this purported agency relationship, the originating carriers. Thus, apart from the fact that Neutral Tandem's appearance as an agent for some other carrier that has not filed a petition or complaint against Level 3 cannot cure Neutral Tandem's standing, the limited extent of the agency letter would prohibit an interconnection proceeding under Section 364.16(2), Florida Statutes, would prevent the Commission from addressing the "prices, terms, and conditions" of interconnection between Level 3 and the originating carrier under Section 364.16(2).

On behalf of Level 3, I respectfully reiterate Level 3's opposition to a deferral of this matter beyond the July 10, 2007 Agenda Conference.
