4	MR. BATES: Good morning, Commissioners. I'm Jeff
5	Bates of technical stAff.
6	Item Number 10 is Embarq's petition for waiver of
7	Order Number PSC-96-0012-FOF-TL, and request to establish
8	modified price regulation categories. Staff would like to make
9	an oral modification to the issue identification and
10	recommendation statement for Issue 1. Due to a scrivener's
11	error, FPSC Order Number PSC-96-0012-FOF-TL is shown as
12	PSC-06-0012-FOF-TL.
13	Staff is available to answer any questions you may
14	have, and Embarq representatives are available, as well.
15	CHAIRMAN EDGAR: Thank you.

3	MS. MASTERTON: Well, obviously we would prefer to
4	have the five baskets, that's consistent with what you have
5	previously approved, and it would allow us the greater pricing
6	flexibility that we need to respond to competitive pressures.
7	But to the extent that you don't approve the five, certainly
8	the six would be preferable to the ten.
9	COMMISSIONER ARGENZIANO: Madam Chair, I think the
10	staff option gives me a little bit more certainty. I think it
11	guarantees that there is a basic Lifeline service and it keeps
12	the message service in place without it raising the costs, so I
13	feel more comfortable with the staff option than the
14	recommendation.
15	CHAIRMAN EDGAR: Commissioners, further comment?
16	Commissioner Skop.
17	COMMISSIONER SKOP: I had the same concern when I was
18	meeting with staff. It does provide a little bit more
19	flexibility, although it may be a little bit inconsistent with
20	the previous practice. I think it provides a little bit more
21	visibility as to what's going on there, and it was recommended
22	by staff as an option.
23	And also, two, with respect to the scrivener error,
24	when you were speaking earlier I could not hear pretty much a
25	thing that you were saying just because of the microphone, but
