Post Office Box 15579 Tallahassee, FL 32317 3) Pursuant to the requirements of this Docket, the Company has prefiled the conservation cost recovery forms supplied by the Electric & Gas Department in a manner consistent with the Department's instructions.

4) As indicated in the prefiled forms, the recoverable conservation costs for the period January 2008 through December 2008 are projected to be \$2,600,000. The conservation cost recovery true-up amount for the period January 2007 through December 2007 is an overrecovery of \$524,296.

5) The resulting net total projected conservation costs to be recovered for the period January 2008 through December 2008 are \$2,075,704. Based upon projected sales the appropriate levelized conservation cost recovery factors for the period January 2006 through December 2006 are:

Residential	\$.07231
General Service	\$.03160
Large Volume Service	\$.02190
Large Volume Transportation Service	\$.02190

WHEREFORE, Florida Public Utilities Company petitions the Commission to approve the foregoing conservation cost recovery factors, to be applied to customer bills for the period January,

2008 through December, 2008, and to billings thereafter until other conservation cost recovery

factors are approved by the Commission.
