On the home page (has pictures of our Commissioners at the top), type 060476 in the Quick Search Box. On the page that follows, scroll down to: PSC Dockets - Document Listing - then click on it. You will then see word or pdf files of all documents filed (except confidential). Look at the newer documents first. You will find responses to staff's request for comments about the potential for rate caps on inmate calls. In the next two months, we will file a recommendation for the Commission to decide if there are going to be rate caps on inmate calls or not. There are a lot of documents.

We are hoping to file a recommendation on 9/24 for an Agenda on 10/6. Florida Statutes changed to eliminate authority for the Commission to set rates for operator services. As you can see from the filings, several companies/organizations want the Commission to use the "Public Interest/Monopoly Services" arguments to set inmate rate caps. The Commission will decide what to do at the Agenda on 10/6.

I am not sure how you go about getting on the mailing list for this docket. I have copied Hong Wang. Hong works in the Commission Clerk's Office and she may be able to instruct you on how to go about getting on the list. Or, she may tell you that you can't be added. I will leave that to Hong.

I will e-mail our rules about inmate services later today or tomorrow.


