I talked with Mike Cooke yesterday afternoon. I reminded him that at the meeting Wednesday, we all kind of over looked the fact that Aloha reported being behind on purchasing the property for the booster station; was to be completed 1st week in August. Pasco and DEP permitting was to be completed by 1st week in September and booster station bid awards all done by 2nd week in Oct. We asked if the country water was on schedule and as I recall the reply was positive. Mike remembered it the same way and agreed to look into today.

It appears that other work on Anion is set up for further delays than the 10 months behind after 15 months in the project.

Also we should have a concern when something goes wrong with Anion; Aloha now has no where to go for technical support. As this settlement was prepared, the customers and I suspect that the PSC did not understand that David Porter was not technically competent to implement an Anion project. Aloha should have developed a back up, because in any new start up; we all know things go wrong and technical support is needed. Mike Cook will also look into this today?

Aloha has not updated their web site with new information on anion and the monthly bill arrived with a new

flyer on how to save water. I could sure save a lot of water if I did not need to flush the black out of the system so often. I also told him that Todd Brown of the PSC PR staff did not have the following quite right. "Aloha intends to update its Web site with the new time line and other information, Brown added. The company also might provide customers with project updates through billing inserts on a regular basis." Mike waffled on that a little.

We also discussed the need for Aloha to sell and that the PSC needs to encourage a sale to the county. Mike told me that the PSC only controls 4% of the water in the state of Florida. Perhaps a significant fine and consent order by the PSc would provide some encouragement. We need you help on that. The county is clearly foot dragging on a purchase and at this rate it will never happen. I now appears Ann H being a politician does not tell Gallagher to go get it done!

I expressed my concern that Troy Rendell of the PSC Staff does not appear supportive of the customers recognition of the inflated cost of chloramination being moved forward by Aloha.

We are eager to hear from the OPC water consultant before I push that too much further.

I thank you for being generous enough to talk at length with me last night. The phone connection was not good on my end, so if I spoke loudly, please understand that I was not yelling at you. You obviously comprehend the customers problems and I appreciate your interest and concern for the customers.

I am forwarding the following email as additional background; we have been trying to get the attention of the PSC staff but they appear focused on listening primarily to the utility and therefore it has become necessary for the customers to express their frustration in order to get attention.

It has become clear that the customers were misled in accepting the settlement in March 2006 with promises by PSC Sr. Attorney Rick Melson. We were assured at that time that if there were delays, the PSC would seek deletion for the customers. Next month will be two years later and we are now asking the PSC to honor the promises made to the customers.

As we discussed, the utility proposed connection site is not going to help my water problem and is not good

for the customers for numerous reasons. The utility has cancelled visits to the sites by a water consultant who would be able to substantiate that current connection plans are not appropriate. The OPC consultant's four visits were cancelled in November, December, January and again in February. One excuse after another from the utility. The utility's water consultant from Jacksonville who rarely visits the sites is an inappropriate choice as a tour guide and then to use as an excuse that he is not available is pretty lame. Better choices for a tour guide could possibly be the utility's Manger of Operations or one of the many certified water operators employed by the utility, they are on site every day and know the system inside and out.

Refer to attached December 6, 2007 letter to Aloha from Pasco County.

Item #13 on page 2 recommends that Aloha construct a storage and re-pump facility rather than just a booster pump which they are going forward to the PSC with on January 29th. Aloha has continued to overlook this suggestion from the county and is about to construct a facility which does not include the recommended storage. Storage appears to make a lot of common sense, particularly in light of the fact that with the current plan the utility will be taking much less than the 2.4 mgd of county water than the county agrees to provide. It appears that the storage tank along with booster pumps could allow the utility to shut down the most problematic well #9.

We need to make every effort to keep the utility from going forward with this poor business decision which is contrary to the recommendation of Pasco County. We need to stop this utility from wasting more money which gets charged back to the customers in the form of higher rates.

Item #12 explains that the utility submitted a 60% complete conceptual drawing to the county when seeking the permit. Aloha then complained to the PSC at the last meeting about the county is taking too long to approve the required permit. This sloppy work by Aloha is causing the delays and is reason the PSC should be looking at the deletion promised to the customers by Attorney Melson in March of 2006.

We will look forward to your helping get the utility on track to better decision making and stop the continual process of taking advantage of the customers. The settlement as we see it is not being implemented as agreed to in March 2006.

Dear Mr. Emsberger:

We have reviewed the Aloha Pressure Control Station documents you have provided, including the Drawings signed and sealed on 10/7/07 (also revised sheets 2 and 3; signed and sealed on 11/8/07), Abbreviated Engineering Report and FDEP Permit Application, and have the following comments:


1. The County's standard flow meter with backflow preventer will be used for billing purposes. The flow meter must comport with Pasco Standard Detail '02, which requires the inlet and discharge piping be identical to meter inlet size.
2. The meter and the flow control valve assembly (hereinafter referred to as the "Assembly") must be located together, in a separately fenced area with a minimum of 10 feet clear space around all sides of any piping/electrical facilities for access and maintenance. Provide adequate space for parking for 2 vehicles. Provide fence with barbed wire and 10-foot wide access gate. Provide adequate lighting for nighttime maintenance.
3. Furnish the County with fee simple title to the site or a perpetual easement for operation and maintenance of the Assembly.
4. The supply line upstream of the Assembly will be owned and maintained by the County. As such, if the pipe is not installed in County ROW, an easement must be provided to the County for access and maintenance of this line.
5. The flow control valve (FCV) piping layout must comport with the manufacturer's installation recommendation of 10 diameters upstream and 5 diameters downstream of the meter. The FCV must be provided with rate-of flow, backpressure sustaining and remote open/close (via solenoid) functions.
6. The FCV orifice plate is not an acceptable device and metering should be utilized by the use of a 12x6 compound meter or some other acceptable metering device that accurately measures rate of flow over the existing range.

7. A Rosemount Absolute Pressure Transmitter must be provided on the upstream side of the FCV for local and remote monitoring of the supply pressure to the Assembly.
8. A Pasco County standard Data Flow Systems Remote Telemetry Unit (RTU) with antenna must be installed to allow the County to remotely monitor and control the FCV. The RTU shall have one (1) digital output for open/close control of the FCV (solenoid) and two (2) analog inputs for the flow and pressure signals.
9. Provide a hose bib on the upstream side of the Assembly, within the fenced area, for the County's use.
10. Provide a 120 VAC receptacle within the fenced area for the County's use.
11. Per our maintenance staff, please be advised that we control corrosion in our systems with the addition of sodium chloride which raises the PH level to approximately 7.9-8.0.
12. As mentioned in your cover letter with the submittal, package submitted including report and drawings is conceptual at 60% complete; therefore, it is not appropriate for us to sign the permit application until detailed design is provided.
13. If Aloha elects to proceed with this connection to County water system as presently proposed, be assured that there will be times of the day when the County's system may not be able to deliver water to Aloha due to pressure differences in our systems. As previously discussed, the County still recommends that Aloha construct a storage and re-pump facility to ensure that this connection can deliver an adequate quantity of water to Aloha and Aloha can pump this water into its system at an adequate pressure for its customers during peak hour demand.

Before the County can execute the FDEP Permit Application, Aloha will need to address each of the items listed above. In addition, as provided for in our service agreement, Aloha will need to compensate the County for the engineering services the County's consultant has expended in modeling the proposed connection and basis of design. We will provide you with a summary of these services, and the cost thereof, under separate cover.

On Tuesday, the Aloha Utilities President agreed to allow Steve Reilly of the OPC and the OPC water consultant to do a site review two days after the agenda conference. Yet once again, after Steve Reilly and water consultant Ken Hatcher arrived in Pasco County to do this, Aloha abruptly refused the visit with the excuse that the Aloha consultant from Jacksonville could not be available to accompany them. Is no one else besides a consultant who is located four hours away qualified to provide such a tour? We believe that Mr. Watford, the company president, would be knowledgeable about his water operation and be qualified to lead a tour and unlock gates at the facilities. Further, we also know that the utility is required to have "Certified Water Operators" working for them who clearly would also be able to provide the tour and unlock the gates. Remember, please, the OPC visits in November, December and again in January were also cancelled. This inconsiderate and arrogant action by the utility is appalling to me and should be appalling to each of you also.

In closing, the customers feel that their interest have been neglected and I request reconsideration of the rate increase granted by the PSC to the utility on Tuesday and that enforcement actions against this utility begin.



Dear Mr. Ernsberger:

We have reviewed the Aloha Pressure Control Station documents you have provided, including the Drawings signed and sealed on 10/7/07 (also revised sheets 2 and 3; signed and sealed on 11/8/07), Abbreviated Engineering Report and FDEP Permit Application, and have the following comments:

1. The County's standard flow meter with backflow preventer will be used for billing purposes. The flow meter must comport with Pasco Standard Detail '02, which requires the inlet and discharge piping be identical to meter inlet size.
2. The meter and the flow control valve assembly (hereinafter referred to as the "Assembly") must be located together, in a separately fenced area with a minimum of 10 feet clear space around all sides of any piping/electrical facilities for access and maintenance. Provide adequate space for parking for 2 vehicles. Provide fence with barbed wire and 10-foot wide access gate. Provide adequate lighting for nighttime maintenance.
3. Furnish the County with fee simple title to the site or a perpetual easement for operation and maintenance of the Assembly.
4. The supply line upstream of the Assembly will be owned and maintained by the County. As such, if the pipe is not installed in County ROW, an easement must be provided to the County for access and maintenance of this line.
5. The flow control valve (FCV) piping layout must comport with the manufacturer's installation recommendation of 10 diameters upstream and 5 diameters downstream of the meter. The FCV must be provided with rate-of flow, backpressure sustaining and remote open/close (via solenoid) functions.
6. The FCV orifice plate is not an acceptable device and metering should be utilized by the use of a 12x6 compound meter or some other acceptable metering device that accurately measures rate of flow over the existing range.



7. A Rosemount Absolute Pressure Transmitter must be provided on the upstream side of the FCV for local and remote monitoring of the supply pressure to the Assembly.
8. A Pasco County standard Data Flow Systems Remote Telemetry Unit (RTU) with antenna must be installed to allow the County to remotely monitor and control the FCV. The RTU shall have one (1) digital output for open/close control of the FCV (solenoid) and two (2) analog inputs for the flow and pressure signals.
9. Provide a hose bib on the upstream side of the Assembly, within the fenced area, for the County's use.
10. Provide a 120 VAC receptacle within the fenced area for the County's use.
11. Per our maintenance staff, please be advised that we control corrosion in our systems with the addition of sodium chloride which raises the PH level to approximately 7.9-8.0.
12. As mentioned in your cover letter with the submittal package submitted including report and drawings is conceptual at 60% complete; therefore, it is not appropriate for us to sign the permit application until detailed design is provided.
13. If Aloha elects to proceed with this connection to County water system as presently proposed, be assured that there will be times of the day when the County's system may not be able to deliver water to Aloha due to pressure differences in our systems. As previously discussed, the County still recommends that Aloha construct a storage and re-pump facility to ensure that this connection can deliver an adequate quantity of water to Aloha and Aloha can pump this water into its system at an adequate pressure for its customers during peak hour demand.

Before the County can execute the FDEP Permit Application, Aloha will need to address each of the items listed above. In addition, as provided for in our service agreement, Aloha will need to compensate the County for the engineering services the County's consultant has expended in modeling the proposed connection and basis of design. We will provide you with a summary of these services, and the cost thereof, under separate cover.

This letter is in response to your letter of December 6, 2007, in which you enumerated a number of additional items (13), which must be accomplished before you will be able to sign the FDEP Permit application for Aloha. Please remember that we left our review meeting with you and Mr. Hanna with the understanding that we needed only to revise the drawings to show the meter and flow control valve assembly on the station site and show the meter assembly in accordance with your detail furnished to us by Mr. Hanna. Imagine our chagrin after receiving your letter; however, we intend to comply with your request as outlined below in order to get this project back on schedule.

We will address your comments in order:

1. **The County's standard flow meter with backflow preventer will be used for billing purposes. The flow meter must comport with Pasco Standard Detail 02, which requires the inlet and discharge piping be identical to meter inlet size.**

Response: The meter assembly detail will be revised to reduce pipe size at each end of the assembly, below grade, in accordance with the detail.

2. **The meter and the flow control valve assembly hereafter referred to as the "Assembly" must be located together, in a separately fenced area with a minimum of 10 feet clear space around all sides of any piping/electrical facilities for access and maintenance. Provide adequate space for parking for 2 vehicles. Provide fence with barbed wire and 10-foot wide access gate. Provide adequate lighting for nighttime maintenance.**

Response: We will hereafter refer to the meter and flow control valve assembly as the "Assembly". Two parking spaces will be provided. Piping will be moved to provide 10 feet on each side of the "Assembly". It will be surrounded by a six-foot

chain-link fence with three strands of barbed wire on top. A weatherproof duplex receptacle will be provided for use with portable lighting systems.

- 3. Furnish the County with fee simple title to the site or a perpetual easement for operation and maintenance of the Assembly.**

Response: As we have previously discussed, this facility is temporary and will be removed when the permanent storage & pumping station is constructed. At that time, the meter will be relocated to a permanent location with fee simple title or perpetual easement.

- 4. The supply line upstream of the Assembly will be owned and maintained by the County. As such, if the pipe is not installed in County ROW, an easement must be provided to the County for access and maintenance of this line.**

Response: OK

- 5. The flow control valve (FCV) piping layout must comport with the manufacturers installation recommendation of 10 diameters upstream and 5 diameters downstream of the meter. The FCV must be provided with rate-of-flow, backpressure sustaining and remote open/close (via solenoid)- functions.**

Response: The FCV will comport with the manufacturers installation recommendations, however, there does not appear to be any requirements for the FCV to be mounted 10 diameters upstream and 5 diameters downstream of the meter. The installation will accommodate the meter manufacturers' setback requirements. A remote open-close solenoid valve can be provided for Pasco County Water System to immediately shut off water to Aloha. A pressure sustaining function will be added to the valve.

- 6. The FCV orifice plate is not an acceptable device and metering should be utilized by the use of a 12x6 compound meter or some other acceptable metering device that accurately measures rate of flow over the existing range.**

Response: The orifice plate is not utilized for measuring flow rate directly, but is used to create a pressure differential that can be calibrated against the meter.

CLA-VAL has been contacted and is exploring the possibility of controlling the valve via signal output from the meter. If so, it will be installed.

7. **A Rosemount Absolute Pressure Transmitter must be provided on the upstream side of the FCV for local and remote monitoring of the supply pressure to the Assembly.**

Response: A Rosemount Absolute Pressure Transmitter will be provided but we intend to set the Pressure Transmitter to measure Gage pressure, instead of Absolute pressure.

8. **A Pasco County standard Data Flow Systems Remote Telemetry Unit (RTU) with antenna must be installed to allow the County to remotely monitor and control the FCV. The RTU shall have one (1) digital output for open/close control of the FCV (solenoid) and two (2) analog inputs for the flow and pressure signals.**

Response: These will be provided.

9. **Provide a hose bib on the upstream side of the Assembly, within the fenced area, for the County's use.**

Response: A hose bib will be provided.

10. **Provide a 120 VAC receptacle within the-fenced area for the County's use.**

Response: A 120 VAC receptacle will be so provided.

11. **Per our maintenance staff, please be advised that we control corrosion in our systems with the addition of sodium chloride which raises the PH level to approximately 7.9-8.0.**

Response: We believe you mean Sodium Hydroxide instead of Sodium Chloride. We understand that Pasco County uses Sodium Hydroxide to raise the pH. This will not affect Alohas' system.

12. As mentioned in your cover letter with the submittal, package submitted including report and drawings is conceptual at 60% complete; therefore, it is not appropriate for us to sign the permit application until detailed design is provided.

Response: At our meeting in your office, you apparently thought it was appropriate, in that you stated that if we revised the drawings to show the meter installation inside the project site, and include the Flow Control Valve in the meter assembly in accordance with your detail, you would sign the permit application.

We also stated that you would receive 90% and 100% drawing for review prior to bidding the project, and that any necessary changes to suit Pasco County Utilities would be incorporated into the design documents. Drawings at 100% are not necessary for Permitting purposes.

13. If Aloha elects to proceed with this connection to County water system as presently proposed, be assured that there will be times of the day when the County's system may not be able to deliver water to Aloha due to pressure differences in our systems. As previously discussed, the County still recommends that Aloha construct a storage and re-pump facility to ensure that this connection can deliver an adequate quantity of water to Aloha and Aloha can pump this water into its system at an adequate pressure for its customers during peak hour demand.

Response: Aloha understands this and asks no more than that Pasco county honor the terms of service set forth in their service agreement with Aloha Utilities. Aloha intends to construct storage and pumping facilities to serve their customers as the second phase of their work under the terms of the service agreement.

14. Before the County can execute the FDEP Permit Application, Aloha will need to address each of the items listed above. In addition, as provided for in our service agreement Aloha will need to compensate the County for the engineering services the County's consultant has expended in modeling the proposed connection and basis of design. We will provide you with a summary these services and the cost thereof; under separate cover.





It's understandable that state Sen. Mike Fasano and other officials want Pasco County government to purchase west-Pasco based Aloha Utilities. Customer service and water quality issues have plagued the utility for years, and dozens of orders by state regulators have failed to solve them, leaving customers frustrated and angry.

Indeed, the county's purchase of Aloha would bring local accountability, something that has been lacking, and Pasco Utilities has a very good track record of providing quality service and water. It would be a good fit.

But that doesn't mean it should happen, for several reasons.

Foremost, the county and taxpayers would be purchasing a utility that has failed to get its act together. Taxpayers—both local and statewide—should never be asked to pony up money to purchase an inferior product and, at the same time, reward its owner with millions of dollars. That's what would happen if the county purchased Aloha Utilities at this point.

Money and willingness on the part of Aloha are other issues. The utility hasn't even agreed to sell, and it's hard to believe it would be satisfied with only the \$6 million that Fasano and other legislators plan to seek in the next legislative session.

How much should taxpayers be expected to pay? Considering Aloha's record, \$6 million is excessive. And county officials should not expose taxpayers to further debt to purchase it. They have more pressing issues, such as addressing transportation deficiencies and solid-waste disposal issues.


Because Aloha has a long history of playing hardball with Fasano and the state Public Service Commission, which regulates it, it's a safe bet it will seek to extract every cent from taxpayers that it can. The utility's vow to fight any effort by the state to yank its franchise and turn its Seven Springs service area over to the county—still a possibility—only reinforces that taxpayers could be exposed to a bad business deal.

Fasano, the driving force behind a county purchase, and other supporters of the possible purchase have very good intentions: to finally give customers the relief that state regulators have failed to produce. But that relief should not come at the expense of all taxpayers, who would be taking on a headache that previously had been experienced by a relatively small number.

This isn't to suggest that a county purchase should never be pursued. But the best solution at this point is to reinstitute territory-deletion proceedings against Aloha, which Fasano has requested, and for county officials to try to take over local utility regulation now handled by the PSC, which state law allows.

County May Lack Money For Aloha

NEW PORT RICHEY - To hear the politicians tell it, Aloha Utilities is up for grabs.

In recent weeks, a flurry of movement from state lawmakers has seemed to indicate that Pasco County officials are nearing a deal to buy the private tap water and wastewater provider, one of several utilities they have been eyeing for possible acquisition.

Leading the charge is Sen. Mike Fasano, R-New Port Richey, an Aloha customer and longtime critic who, two weeks ago, asked the Florida Public Service Commission to turn the utility's service area over to the county.

And Thursday night, Pasco's legislative delegation endorsed a bill that would, if approved by the Legislature and signed by the governor, provide \$6 million to the county as seed money to purchase New Port Richey-based Aloha.

Fasano called the company a "threat" to the environment and the health of its 25,000 customers.

"Aloha is one of the worst corporations in this country," the Republican lawmaker said.

Thing is, there's no indication that Aloha is even interested in selling its franchise or, for that matter, whether the county could afford the multimillion-dollar price tag.

Aloha President Steve Watford has declined to comment on the issue and previously pledged to fight attempts by the state or county to take over his franchise.

County Commissioner Ann Hildebrand said she and other senior county officials met with Watford several weeks ago to discuss their interest in acquiring his company. Aloha made no commitments during that meeting, she said.

"The best of all worlds is a willing seller and a willing buyer," Hildebrand said. "We're not there yet. They told us that they would get back to us, but we haven't heard from them."

The \$6 million in seed money wouldn't go far in buying the utility, she said. And Hildebrand doubts the allocation will even make it to the governor's desk.

John Wharton, Aloha's attorney, said Thursday night that the efforts by state lawmakers to intervene are hurting the discussions between Aloha and the county.

"It's not helpful," he said.

Wharton also took issue with the wording of Fasano's legislation.

"I have never seen a bill with this kind of language," Wharton told the delegation. "It would probably be libelous if it were not for the protection that the body that you all serve on has."

County officials have pushed for years to tie small utilities into regional water systems amid complaints from customers about poor water quality and service, and high rates.

In 2001, Pasco County Utilities Services - which pumps an average of 20 million gallons of water a day to about 100,000 residents - looked at buying 14 local utilities, including Aloha. But after months of negotiations, the agency managed to acquire only three of them.

Aloha customer John Andrews said he supports the county's efforts to buy the water provider.

"It's time for bold new actions by our government to end the suffering," he told the legislators. "The key words are deletion, removal and acquisition."
