PETITION TO DETERMINE NEED FOR TURKEY POINT NUCLEAR UNITS 6 AND 7

NOTICE is hereby given pursuant to Rule 25-22.080(3), Florida Administrative Code, that the Florida Public Service Commission has received the petition of Florida Power & Light Company (FPL) for a determination of need for proposed electrical power plants in Dade County. FPL's proposal consists of two nuclear generating units, which will contribute between 2,200 and 3,040 MW of new generation. The petitioner proposes the construction of two nuclear facilities located adjacent to FPL's current Turkey Point complex. The proposed in-service dates for the proposed units are 2018 and 2020. This matter has been assigned Commission Docket No. 070650-EI.


