FLORIDA POWER & LIGHT COMPANY'S REQUEST FOR CONFIDENTIAL CLASSIFICATION

NOW, BEFORE THIS COMMISSION, through undersigned counsel, comes Florida Power & Light Company ("FPL") and, pursuant to Rule 25-22.006 of the Florida Administrative Code and Section 366.093 of the Florida Statutes, hereby requests confidential classification of certain information retained by the Florida Public Service Commission ("Commission") staff ("Staff") in connection with Staff Audit No. 07-164-4-1 ("the Audit"). In support of its request, FPL states as follows:

- 1. During the Audit, Staff requested access to various FPL documents. By letter dated October 7, 2007, Staff indicated its intent to retain certain audit work papers. Pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, FPL was given 21 days from the date of the letter to file a formal request for confidential classification with respect to such work papers.
 - 2. The following exhibits are included herewith and made a part of this request:
 - a. Exhibit A consists of the documents for which FPL seeks confidential treatment. All information in Exhibit A that FPL asserts is entitled to confidential treatment has been highlighted. Exhibit A is submitted separately in a sealed folder marked "CONFIDENTIAL."
 - b. Exhibit B consists of edited versions of all documents for which FPL seeks confidential treatment. All information for which FPL requests confidential treatment has

been redacted in Exhibit B.

- c. Exhibit C is a table containing a line-by-line and page-by-page identification of the information for which confidential treatment is sought and, with regard to each document or portions thereof, references to the specific statutory basis or bases for the claim of confidentiality and to the affidavits in support of the requested classification.
- d. Composite Exhibit D includes the affidavits of Frank Irizarry, Gerard Yupp, Robert Birch, and Osvaldo Lom.
- 3. FPL submits that the highlighted information in Exhibit A is proprietary confidential business information within the meaning of Section 366.093(3), Florida Statutes. To the best of FPL's knowledge, the highlighted information has not been publicly disclosed. Pursuant to Section 366.093, such information is entitled to confidential treatment and is exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information.
- 4. As the affidavits in Composite Exhibit D indicate, certain highlighted information consists of contractual vendor data, such as pricing and other terms, the disclosure of which would impair the efforts of FPL to contract for goods or services on favorable terms in the future, to the detriment of FPL and its customers. This information is protected by Section 366.093(3)(d), Florida Statutes. In addition, certain information is competitively sensitive data that, if disclosed, would place FPL at a competitive disadvantage and would also harm the competitive interests of FPL's contractors and vendors, because disclosure of such information could afford their competitors an unfair advantage in competing for both FPL and non-FPL

contracts. This information is protected by Section 366.093(3)(e), Florida Statutes.

5. Upon a finding by the Commission that the material in Exhibit A for which FPL

seeks confidential treatment is proprietary confidential business information within the meaning

of Section 366.093(3), such information should not be declassified for a period of at least

eighteen (18) months. FPL further requests that the material be returned to FPL as soon as the

information is no longer necessary for the Commission to conduct its business, pursuant to

Section 366.093(4).

WHEREFORE, for the above and foregoing reasons, as more fully set forth in the

supporting materials and affidavits included herewith, Florida Power & Light Company

respectfully requests that its Request for Confidential Classification be granted.
