The Florida Public Service Commission is currently involved in a wastewater rate proceeding with KWR (WWTP - FLA014951). An important part of this proceeding is the quality of service provided by this utility. A major component of our quality of service recommendation is the consideration of the utility's compliance. It is essential that your staff answer the questions in the attached prefiled testimony.


