


## APPLICATION TO CANCEL CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

**COMES NOW,** TransAmerica Telecom, Inc. ("TTI") and in support of its Application to cancel its Registration as an intrastate interexchange providers states the following:

- 1. On September 14, 2006, TTI registered with the Florida Public Service Commission to provide intrastate interexchange telecommunications service which Registration was issued on September 15, 2006 in Docket No. 060627-TI.
- 2. Due to a change in the business direction of the company TTI no longer seeks to be a provider of intrastate interexchange telecommunications services within the State of Florida.
- 3. Since the filing of the registration, TTI has neither provisioned service nor invoiced customers in the State of Florida. As a result, cancellation of TTI's Registration is reasonable and would not be unduly disruptive to the present or future public convenience.
