
Dear Ms. Cole:

DESCRIPTION OF TERRITORY SERVED

Parcel 1 – Livingston Road property

A portion of the North 696 feet of the West 437.5 feet of the Northwest ¼ of the Northeast ¼ of Section 32, Township 26 South, Range 19 East, Pasco County, Florida, abounded and described as follows:

Commence at the Northeast corner of said tract and run South 396 feet for a Point of Beginning. Thence from said point, the following six courses:

S 01° 01' 43" W, 300 feet; thence N 88° 58' 21" W, 437.29 feet; thence N 01° 01' 43" E, 272.31 feet; thence S 88° 14' 18" E, 242.50 feet; thence N 01° 01' 43" E, 27.96 feet; thence S 88° 58' 21" E, 194.81 feet to the aforementioned Point of Beginning.

LESS AND EXCEPT THE FOLLOWING:

A portion of the Northeast ¼ of the Northwest ¼ and a portion of the Northwest ¼ of the Northeast ¼ of Section 32, Township 26 South, Range 19 East, Pasco County, Florida, described as follows:

Commence at the North ¼ corner of Section 32, Township 26 South, Range 19 East, and run S 01° 01' 43" W, a distance of 423.59 feet along the west boundary of the Northwest ¼ of the Northeast ¼ of Section 32 to the Point of Beginning. Thence from said Point of Beginning the following seven courses:

S 88° 14' 18" E, 16.33 feet; thence S 00° 43' 23" W, 272.11 feet; thence N 88° 58' 21" W, 17.78 feet; thence N 00° 01' 43" E, 228.90 feet; thence N 88° 46' 48" W, 8.23 feet; thence N 00° 51' 52" E, 43.49 feet; thence S 88° 14' 18" E, 8.36 feet to the aforementioned Point of Beginning.
