Dear Ken:

This is to follow-up my September 10, 2007, e-mail which, among other things, included tariff changes needed in the above-referenced docket. Now that the application has been approved by the Commission and an order issued, this letter specifically describes the changes to Aqua Utilities Florida, Inc.'s (AUFI's) tariff needed to conclude this docket. It is staff's preference that only the tariff changes needed for this amendment be filed in this docket. A separate letter will describe the tariff changes needed to conclude Docket No. 070361-WU.

Attached to this letter, and summarized below, the tariff revisions for this docket. All the tariff sheets are in Volume I – Section II of AUFI's tariff. In general, the tariff changes previously filed for the Lake County indexes were correct. However, the changes to the summary indexes at the beginning of the section on territory were overlooked.

1. <u>Tariff Sheet No. 2.0</u> needs a first revision to add the amendment order at the top of East Lake Harris Estates' system.

2. <u>Tariff Sheet No. 3.0</u> needs a first revision to add the community of Harbor Isle to the East Lake Harris Estates' system.

3. <u>First Revised Tariff Sheet No. 40.0</u>, as filed, needs the order information added. Also note that something happened to the right-hand margin to force the word "Certificate" in the Filing Type column for Order No. 5939 to the next line.

4. <u>First Revised Tariff Sheet No. 41.0</u>, as filed, needs Harbor Isle alphabetized under the first column, "Community Name." Also, you need to pay attention to font incompatibilities between the Word versions used by the Commission and the utility. As a consequence, the underscoring in the header is cut off short. Also the word

"Description" in the header for the third column is thrown to the next line under the first column header.

5. <u>Original Tariff Sheet No. 43.1</u>, as filed, is in the correct location. However, please notice the format used for the other legal descriptions. The system name is first, followed by the community name, followed by the order, followed by the township and range, followed by the section. I have included Tariff Sheet No. 43.0 as an example.
