

**AT&T FLORIDA'S NOTICE OF WITHDRAWAL OF MOTION TO
DISMISS OR, IN THE ALTERNATIVE, TO HOLD IN ABEYANCE**

BellSouth Telecommunications, Inc. d/b/a AT&T Florida ("AT&T Florida") hereby gives Notice of Withdrawal of its Motion to Dismiss Or, In the Alternative, To Hold in Abeyance, Intrado Communications, Inc.'s ("Intrado") Petition for Arbitration, and states the following:

1. At the time Intrado filed its Petition for Arbitration, the parties had not negotiated the issues raised by the Petition. Accordingly, AT&T Florida filed its Motion to Dismiss Or, In the Alternative, To Hold In Abeyance to obtain adequate time to allow negotiation to take place before the case progresses. It now appears that the case schedule in this proceeding will be set so that the parties will have adequate time to negotiate before testimony is due to be filed, which obviates the need for the Motion. Accordingly, AT&T Florida hereby withdraws its Motion to Dismiss Or, In the Alternative, To Hold in Abeyance, Intrado's Petition for Arbitration.


