

To the extent applicable, include in your answer a description of the equipment committed contractually to serving Progress Energy's needs, and terms addressing number and capacity of barges to be made available pursuant to the contract(s), frequency of deliveries, and/or tons to be delivered.

6. Please describe any changes to, or increases in, the number of barges employed in the transportation of coal across the Gulf of Mexico to Crystal River; the size or

capacity of such barges; the frequency of deliveries; and/or the total quantity of coal to be transported since January 1, 2005.
