

Dear Mr. Perez:

I received your voice mail message about cancelling the company's IXC registration. The company must request cancellation in writing and pay any outstanding Regulatory Assessment Fees. The Regulatory Assessment Fee is applicable if a registration is active for any day during a calendar year. The only exception is if a company requests cancellation by the due date of Regulatory Assessment Fee. In other words, if you postmark the letter requesting cancellation by January 30, 2008, we will make the effective date of the cancellation December 31, 2007. That way, the company will not also owe the 2008 minimum fee. If the request for cancellation and payment of the Regulatory Assessment Fee is postmarked January 31, 2008, and after, the company will also be responsible for the 2008 fee. That is all the company has to do as far as this Commission is concerned. Please let me know if you have any questions. Thanks.
