NuVox Communications, Inc. ("NuVox") hereby files its AMENDED response to Staff's 2008 Local Competition Data Request, and requests confidential classification for certain portions thereof pursuant to Section 364.183(1), Florida Statutes.

On April 15, 2008, NuVox advised Staff that it did not have exchange data available, but that it would provide such data no later than April 22, 2008. Since that time, NuVox worked diligently to convert available data, and accordingly, is amending its prior response.

OMP 1 Pursuant to Rule 25-22.006(5), F.A.C., enclosed please find two redacted copies of NuVox's amended 2008 data tables. These copies replace the redacted version filed yesterday.
COM Also enclosed with this letter is a sealed envelope marked "CONFIDENTIAL" which contains
CTR one copy of the confidential version of NuVox's amended 2008 data tables and a confidential
SCR CD with the corresponding amended confidential file. As required by Rule 25-22.006(5),
GOL Florida Administrative Code, confidential information in the paper documents has been
OPC highlighted, while such information has been redacted from the public responses. Confidential
RCA information in the data files on the CD has been highlighted, however NuVox considers the
SCR entire CD to be confidential.

Pursuant to §364.183(1), Florida Statutes, NuVox claims that highlighted portions of the paper copies in the sealed envelope as well as the entire CD are confidential and proprietary business information belonging to NuVox that should be kept confidential and exempt from public disclosure.
