Stat., and Rule 25-22.006, F.A.C., files this notice of intent to request confidential classification of portions of the testimony and exhibits filed by Lori Cross and Daniel L. Roderick, specifically Ms. Cross' testimony in support of the estimated/actual costs, Ms. Cross's testimony in support of the projected costs, Mr. Roderick's testimony in support of estimated/actual and projected costs, and Exhibit Numbers LC-1, LC-2, LC-4, and LC-5. Specifically, these responses contain sensitive, confidential contractual terms for nuclear goods and services, that if disclosed would result in the impact PEF's ability to contract on favorable terms in the future.

classification and a decision on PEF's request by the Florida Public Service Commission.
