Sandy, I note this item is listed as administrative, but we have a Petition to Intervene by MUUC, and FPL disputes some of the issues raised by MUUC. Therefore, I believe we need a Prehearing Officer assigned to issue an order on MUUC's petition to intervene and FPL's response.

Erik, we need to draft a proposed order for the Prehearing Officer's signature. FPL does not dispute MUUC's right to intervene, but takes issue with two of the issues raised by MUUC. I do not believe we have to have a ruling on whether those issues are appropriate at this time, but merely note that MUUC has demonstrated that it has a substantial interest in these proceedings and that intervention is appropriate.
