To ensure that electric utilities in Florida, such as Tampa Electric Company (TECO) and Withlacoochee River Electric Cooperative, Inc. (WREC) are able to provide reliable, economical service to their customers, without unnecessary duplication of facilities, "territorial boundaries" are established according to geographical areas that decide exclusive areas that each company will serve. Those boundaries are monitored and approved by the Public Service Commission in Tallahassee.

The purpose of this letter is to advise you that Tampa Electric Company and Withlacoochee River Electric Cooperative, Inc. filed a petition with the Florida Public Service Commission on March 7, 2008 requesting approval of a permanent change in the existing service territory in the Meadow Point subdivision. As you may know, the currently approved service territory boundary between WREC and TECO transects Meadow Point in a manner that does not follow the topography and street grids in a logical manner. Withlacoochee and Tampa Electric have asked the Commission modify their existing service territory boundary in Meadow Point so that groups of lots currently transected by the existing boundary line can be served entirely by one Petitioner or the other.
