Intrado Communications Inc. ("Intrado Comm"), by its attorneys, hereby respectfully requests that the Florida Public Service Commission ("Commission") establish a procedural schedule in connection with the above-referenced arbitration proceeding. On April 11, 2008, the Commission issued an order granting the Parties' joint request to hold the arbitration in abeyance for sixty (60) days to allow for further negotiations. The April 11 Order also required the Parties to notify the Commission at the end of the 60-day period whether they are ready to move forward with the arbitration proceeding.

Intrado Comm seeks to proceed with the arbitration. While the Parties have resolved several issues and further clarified those that remain, the Parties have been unable to reach a negotiated resolution on every outstanding issue. Accordingly, Intrado Comm requires Commission assistance to reach a mutually beneficial interconnection agreement with Verizon.

An interconnection arrangement with Verizon will facilitate Intrado Comm's efforts to offer competitive services to public safety organizations and the general public in Florida. As the Commission is aware, Intrado Comm seeks to offer a competitive alternative to the incumbent 911/E911 network. To do so, however, Intrado Comm requires interconnection with incumbent local exchange carriers such as Verizon to ensure that the customers of each carrier can seamlessly complete or receive life-saving emergency calls. Intrado Comm cannot offer services in Florida without establishing the necessary interconnection arrangements with Verizon.

Accordingly, Intrado Comm respectfully requests that the Commission establish a procedural schedule for Intrado Comm's petition starting with an issue ID session in July and arbitration hearings in October or November. The Commission's efforts to address Intrado Comm's petition will promote the goals of competition in Florida as well as promote the development and implementation of new and enhanced 911 services.
