



BEFORE ME, the undersigned authority, personally appeared Paul Markovich who, being first duly sworn, deposes and says:



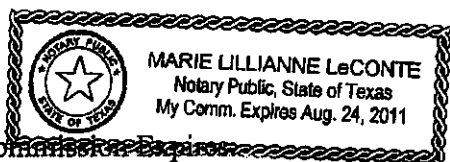
