

29. The Response to data request number one is incomplete. Please list any states in which Swiftel provides Lifeline service and indicate whether that Lifeline service is provided through Resale, UNEs, or a combination of both.

RESPONSE: Swiftel provides lifeline service in Florida and Alabama, and will begin providing service in Kentucky on July 18, 2008. At this time, all lifeline services are provided via resale.

30. Has Swiftel been certificated in any other state to provide telecommunications service? If so, please list the state(s) and docket number(s).

RESPONSE: Swiftel is certified to sell service in Alabama, Kentucky, Oregon, Washington, Montana. Swiftel has applications for certification pending in Tennessee and North Carolina

33. Has Swiftel been denied ETC status by any states? If so, please name the state(s), docket number(s) and the reason.

RESPONSE: Swiftel has not been denied ETC status in any state.

34. Has Swiftel withdrawn any petitions to provide telecommunications service or requested ETC status in any other state? If so, please name the state(s), docket number(s) and the reason.

RESPONSE: No.

35. Of the 1,201 active residential lines mentioned in response to data request number five, how many are provided through resale, and how many are provided through switched port/loop combination UNEs?

RESPONSE: At this time, all services are provided through resale.

36. Swiftel's petition is requesting ETC status in BellSouth's territory, yet Swiftel lists Sprint and Verizon wire centers in the attachment. Please verify that Swiftel is only requesting ETC status for BellSouth's territory and that the listing of Sprint (Embarq) and Verizon wire centers should be deleted.

RESPONSE: Swiftel is requesting ETC designation in AT&T (Bellsouth) and Verizon.

37. I have information indicating that answers to questions 25 and 26 are not correct. Please verify all present and past owners and corporate officers of Swiftel, and indicate if they are owners or officers of any other telecommunication companies.

RESPONSE: The company was originally organized under Tom Biddix as the registered agent. Mr. Biddix released himself from any part of the company. It was then signed over to Angie Watson f/k/a Angie Franco Managing Member 100%. Swiftel later made an amendment to Add Mr. Leonard Solt as a managing member with 50% ownership of Swiftel, LLC. Neither Mr. Solt or Angie Watson own or are any part of any other telecommunications companies. All of these amendments can be found in the original application for certification in Florida.

38. In Swiftel's original petition to provide CLEC service in Florida (Docket No. 070153-TX), one of the credit references provided was Mr. Steve Watson of Lost Key Telecom, Inc. of Pensacola. Is Angela Watson related to Steve Watson? If so, please explain.

RESPONSE: Yes Angie Watson is related to Mr. Steve Watson although not at the time of application. Lost Key telecom had recognition of Angie Watson building Swiftel, LLC and had firsthand knowledge of her creditworthiness.

39. What type of relationship, if any, is there between Lost Key Telecom and Swiftel?

RESPONSE: There is no relationship between Lost Key Telecom, Inc and Swiftel, LLC. Mr. Steve Watson is the father in law of Mrs. Angie Watson

40. Does Angela Watson have any family members that are currently or in the past, been officers or owners of any telecommunication companies? If so, please list the person, their relationship, the company, and their position with that company.

RESPONSE: Yes. Angie Watson is married to Christopher Watson as of September 1, 2007. It is Angie Watson's understanding that the Watson Family owned Teleconex from 1996 until 2003 when the company was sold. According to Mrs. Watson, Mr. Steve Watson was the President and Mr. Chris Watson was the Vice President. Mrs. Angie Watson did not know or have any knowledge of the Watson Family during the time that this company was owned or operated by the Watson Family. They no longer own any telecommunications companies as of 2003 when they sold Teleconex.
