3. Points of geographic areas of service affected;

InteraTel, LLC is authorized to provide service in the following states:

California, Colorado, Florida, Georgia, Indiana, Kentucky, Montana, Nevada, Oregon, Pennsylvania, Texas, Washington and Wisconsin.

4. Brief description of type of service affected

InteraTel, LLC was authorized to provide local and interexchange telecommunications services; however, the Company never initiated the provision of telecommunications services in these states or at the Federal level.

- 5. InteraTel, LLC is non-dominant with respect to the services being discontinued. The public convenience and necessity will not be adversely affected, because customers will be able to receive the same service or a reasonable substitute from a wide array of other carriers throughout the country.
- 6. InteraTel, LLC has not commenced the provision of telecommunications services since it was authorized. As such, the Company does not have any presubscribed nor casual customers. Consequently, customer notice is not applicable. Notice has been sent to the State Regulatory Commissions' and Governors' offices as required under Section 63.71, concurrent with the instant filing with the FCC.

Wherefore, InteraTel, LLC respectfully requests permission to withdraw its authority to provide common carrier services as described above effective August 1, 2008. The company will file to relinquish its authority to provide resold common carrier services in all states in which it was granted authority by this date.
