**NOTICE OF WITHDRAWAL OF PETITION BY

Florida City Gas ("City Gas" or "the Company") hereby submits this Notice of Withdrawal, and as the basis therefore, states:

In the weeks since Florida City Gas filed its July 22, 2008, Petition requesting a mid-course correction to its PGA Cap, City Gas has continued to monitor the fluctuations and trends in the price of natural gas. The recent decline in prices has continued and City Gas now believes that it will be able to manage its purchases for the remainder of the year in a manner that will avoid any significant over-recovery or under-recovery through the PGA clause under the cap that is presently in effect.

WHEREFORE, in order to avoid unnecessary expenditure of resources by the Company and the Commission, City Gas hereby withdraws its July 22, 2008, Petition for Approval of a Mid-Course Correction..
