This is in response to your letter of September 12, 2008 to the Florida Public Service Commission objecting to Aqua Utilities, Inc.'s request to extend its service territory in Pasco County as described in the legal notice published August 12, 2008. The stated basis for your objection and request for a formal hearing is that the expansion described in the legal notice includes area presently being served by Pasco County Utilities.

My understanding is that the legal notice Pasco County is basing its September 12 objection on does, in fact, include area currently served by Pasco County Utilities. However, as you recognize in your letter, the inclusion of a portion of the County's service area in the legal description was a mistake. I am informed that Mr. Carl D. Smith of Aqua Utilities, Inc. has provided Mr. Kenneth Mathewson of Pasco County Utilities with a corrected legal description that properly describes the extension territory sought by Aqua and, further, that Mr. Mathewson has confirmed that this legal description does not infringe on the service territory of Pasco County Utilities.
