**NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION**

1. Gulf Power Company ["Gulf Power", "Gulf", or "the Company"], by and through its undersigned attorneys and pursuant to Rule 25-22.006, Florida Administrative Code, hereby gives notice that it intends to request confidential classification for portions of documents produced in response to request number 15 of Commission Staff's Fourth Request for Production of Documents (No. 13-15) (the "Confidential Documents"). Copies of the Confidential Documents are attached hereto as Exhibit "A."

2. The Confidential Documents consist of Field Visit Reports produced by Southern Company Services employees. Portions of these Field Visit Reports contain detailed, non-public information relating to the mining operations of one of Gulf Power's coal suppliers. Public disclosure of this information could damage the supplier's ability to compete in the marketplace which could, in turn, result in the supplier's (and other suppliers like it) refusing to conduct business with Gulf Power in the future. This information is entitled to confidential classification pursuant to section 366.093(d) and (e), Florida Statutes.

3. Gulf intends to file a formal request for confidential classification within the time period specified in Rule 25-22.006(3)(a), Florida Administrative Code, if the Staff determines that the information will be retained by the Commission and not returned to Gulf Power Company within the specified time period. In the event the Staff determines that it will retain this information, Gulf Power Company requests to be notified, through the undersigned counsel,

prior to the expiration of the period specified in Rule 25-22.006(3)(a).


