AMENDMENT TO APPLICATION FOR CERTIFICATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

Express Phone Service, Inc. ("Express Phone" or the "Applicant"), herby amends its application for certification as an Eligible Telecommunications Carrier (the "Application").

I. Background

Express Phone filed the Application in this Docket on March 31, 2008. The Application was supplemented by General Data Requests, as well as an Affidavit, and a letter clarifying the Designated Service Area. Express Phone is filing this Amendment to its Application in order to clarify one main point. Express Phone does not currently provide service using unbundled network elements, but intends to provide service utilizing UNE's upon certification as an ETC.

II. Amendment to Application

Based upon the foregoing, Express Phone hereby amends the Application, by deleting Sections 5. and 9. of the Application, and replacing such Sections in their entirety with the following:

- 5. Express Phone will offer all of the supported services enumerated under Section 254(c) using facilities obtained as UNEs. According to FCC Rules, facilities obtained as UNEs satisfy the requirement that an ETC provide the supported services using either its own facilities or a combination of its own facilities and resale of another carrier's services. Accordingly, the Applicant satisfies the requirement set forth in Section 214(e)(1)(A).
- 9. Express Phone will serve the exchanges where it leases UNEs or resells the services of the non-rural telephone companies in the state of Florida. Express Phone does not seek certification as an ETC in any areas served by rural telephone companies. Express Phone is not requesting to provide service in any tribal areas in the State of Florida.

Section 54.201(f) of the FCC's Rules states, "[f]or the purposes of this section, the term 'own facilities' includes, but is not limited to, facilities obtained as unbundled network elements pursuant to Part 51 of this chapter, provided that such facilities meet the definition of the term 'facilities' under this subpart." 47 C.F.R. § 54.201(f). The term "facilities" under Section 54.201 is defined as " any physical components of the telecommunications network that are used in the transmission or routing of the services that are designated for support pursuant to subpart B of this part." 47 C.F.R. § 54.201(e). Express Phone's use of UNEs, including § 251 loops, or equivalents thereof, commingled with § 271 elements provided pursuant to an agreement filed with the Commission pursuant to § 252, meets this definition of "facilities."

III. Relief Requested

Express Phone respectfully requests that the Commission grant the Application, as amended herein, and designate the Applicant as an ETC for the Designated Service Area.
