**PEOPLES GAS SYSTEM'S
PRELIMINARY LIST OF ISSUES AND POSITIONS**

Peoples Gas System ("PGS"), by its undersigned attorneys, submits the following Preliminary List of Issues and Positions:

Generic Purchased Gas Adjustment Issues

ISSUE 1: What are the final purchased gas adjustment true-up amounts for the period January 2007 through December 2007?

PGS: \$2,129,695 underrecovery

ISSUE 2: What are the actual/estimated purchased gas adjustment true-up amounts for the period January 2008 through December 2008?

PGS: \$2,578,283 overrecovery

ISSUE 3: What are the total purchased gas adjustment amounts to be collected during the period January 2009 through December 2009?

PGS: \$201,662,572

ISSUE 4: What are the appropriate levelized purchased gas cost recovery (cap) factors for the period January 2009 through December 2009?

PGS: \$1.51426 per therm

ISSUE 5: What should be the effective date of the new purchased gas adjustment charge for billing purposes?

PGS: The charge should be effective beginning with the specified purchased gas cost recovery cycle and thereafter for the period January 2009 through December 2009. Billing cycles may start before January 1, 2009, and the last cycle may be read after December 31, 2009, so that each customer is billed for twelve months regardless of when the adjustment charge became effective.
