

**TAMPA ELECTRIC COMPANY'S
REQUEST FOR TEMPORARY PROTECTIVE ORDER**

Tampa Electric Company ("Tampa Electric" or "the company"), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006(6)(c), Florida Administrative Code, hereby requests a temporary protective order protecting certain information provided to Office of Public Counsel ("OPC") from public disclosure, and in support thereof, says:

1. Rule 25-22.006(6)(c), Florida Administrative Code, provides a procedure allowing a person who permits OPC to inspect or take possession of information to request a temporary protective order exempting the information from Section 119.07(1), Florida Statutes.

2. OPC has requested the production of certain documents, including the documents listed in Exhibit "A" to this request, pursuant to OPC's Production of Documents Request Nos. 106 and 107.

3. The documents listed in Exhibit "A" include confidential information ("Confidential Information") that varies across subject area and that, if disclosed, would be harmful to the interests of Tampa Electric, its parent company, its corporate affiliates and third parties who provide goods and services to Tampa Electric. In particular, the Confidential Information includes numerous proprietary vendor generated and vendor supplied data bases, studies, surveys, job profiles, analyses and other work product the confidentiality of which Tampa Electric is obligated to protect in order to prevent economic and competitive harm to the


provider of such information. As such the Confidential Information is the type of information that Rule 25-22.006(6)(c), Florida Administrative Code, was designed to protect from public disclosure. 
