On behalf of Tele Circuit Network Corp.("Tele Circuit") (CLEC - TX836, IXC - TJ836), this letter is to acknowledge the Florida Public Service Commission ("Commission") of failure of Tele Circuit to submit a report before due date that Commission requested for information from local exchange telecommunications providers which is submitted to the Legislature on the status of competition in the telecommunications industry, which is violation of Section 364.183(1), F.S., Access to Company Records.

In order to improve compliance system, in the month of March of this year Tele Circuit was in the process of transferring and outsourcing all the regulatory tax compliance reporting liabilities to a professional organization named Thomson Tax & Accounting specialized in regulatory tax compliance services. Tele Circuit was of the view that Thomson Accounting would file this report, but according to their statement this data report does not lie under the category of compliance.

Tele Circuit has now has complete understanding what will be filed by Thomson Accounting and other date reports filed by the company directly to the Commission? Tele Circuit also assures the Commission it will not happen again, every single report required to be submitted to the Commission will be monitored and double checked by the company.

In view of the events described in this letter and the fact that Tele Circuit has never violated any Commission's regulation it is requested to lower the penalty for this first violation of Section. 364.183(1). Tele Circuit admits mistake and wants to offer a voluntary contribution to the general revenue fund of \$3500. PROPOSED AGENCY ACTION ORDER IMPOSING PENALTY FOR APPARENT VIOLATION OF SECTION 364.183(1), FLORIDA STATUTES

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

I. <u>Case Background</u>

Section 364.386, Florida Statutes, Reports to the Legislature, requires us to submit a report on August 1st of each year to the President of the Senate, the Speaker of the House of Representatives, and the majority and minority leaders of the Senate and the House of Representatives, on the status of competition in the telecommunications industry. Section 364.386(1)(b), Florida Statutes, specifically requires that this Commission make a request to providers of local exchange telecommunications services on or before March 1 for the data required to complete the report. It also requires the providers of local exchange telecommunications services to our request on or before April 15.

To fulfill these statutory mandates, on February 15, 2008, a data request was mailed via certified mail to all certificated incumbent and competitive local exchange telecommunications companies (ILECs and CLECs) in Florida. The data request included, but was not limited to, explanations of the statutory requirements, the filing requirements, and the potential of penalties for failure to provide a response to the request.

Each of the four companies listed in Attachment A, had not filed a response as the April 15, 2008 deadline approached. We verified that the four companies had signed the certified mail receipt indicating delivery of the data request by the United States Post Office. Because the companies had not responded, a second request was mailed via first-class post on April 7, 2008, reiterating the response due date of April 15, 2008. In addition, attempts were made to contact each company via telephone or e-mail. Each company identified in Attachment A failed to provide a response to letters, telephone calls, or e-mails by the established due dates.

We are vested with jurisdiction over this matter pursuant to Sections 364.183, 364.285 and 364.386, Florida Statutes.

II. Analysis

Section 364.386, Florida Statutes, provides specific dates for this Commission to request information from local exchange telecommunications providers and to submit a report to the Legislature on the status of competition in the telecommunications industry. It also provides a specific date by which local exchange telecommunications providers must submit information to the Commission.

We need information contained in the company records of all Florida ILECs and CLECs to compile the annual competition report for the Legislature. Section 364.183(1), Florida Statutes, Access to Company Records, states in part:

The Commission shall have access to all records of a telecommunications company that are reasonably necessary for the disposition of matters within the Commission's jurisdiction. The Commission shall also have access to those records of a local exchange telecommunications company's affiliated companies, including its parent company, that are reasonably necessary for the disposition of any matter concerning an affiliated transaction or a claim of anticompetitive behavior including claims of cross-subsidization and predatory pricing. The Commission may require a telecommunications company to file records, reports, or other data directly related to matters within the Commission's jurisdiction in the form specified by the Commission and may require such company to retain such information for a designated period of time.

In this instance, four companies failed to provide a response to the data request, effectively denying access to its records. It is imperative that we receive 100% participation to fully reflect the status of local telecommunications competition in its report to the Legislature. All of the companies listed in Attachment A were made aware of our authority to impose penaltics as prescribed by Section 364.285(1), Florida Statutes, should they fail to provide the requested information.

Pursuant to Section 364.285(1), Florida Statutes, we are authorized to impose upon any entity subject to its jurisdiction a penalty of not more than \$25,000 for each day a violation continues, if such entity is found to have *refused to comply with* or *to have willfully violated* any lawful rule or order of this Commission, or any provision of Chapter 364, Florida Statutes.

Section 364.285(1), Florida Statutes, however, does not define what it is to "willfully violate" a rule or order or any provision of this chapter. Nevertheless, it appears plain that the intent of the statutory language is to penalize those who affirmatively act in opposition to a Commission order or rule or any provision of this chapter. See, Florida State Racing Commission v. Ponce de Leon Trotting Association, 151 So.2d 633, 634 & n.4 (Fla. 1963); c.f., McKenzie Tank Lines, Inc. v. McCauley, 418 So.2d 1177, 1181 (Fla. 1st DCA 1982) (there must be an intentional commission of an act violative of a statute with knowledge that such an act is likely to result in serious injury) [citing Smit v. Geyer Detective Agency, Inc., 130 So.2d 882, 884 (Fla. 1961)]. Thus, a "willful violation of law" at least covers an act of commission or an intentional act.

However, "willful violation" need not be limited to acts of commission. The phrase "willful violation" can mean *either* an intentional act of commission or one of omission, that is *failing* to act. <u>See</u>, <u>Nuger v. State Insurance Commissioner</u>, 238 Md. 55, 67, 207 A.2d 619, 625 (1965)[emphasis added]. As the First District Court of Appeal stated, "willfully" can be defined as:

An act or omission is 'willfully' done, if done voluntarily and intentionally and with the specific intent to do something the law forbids, or with the specific intent to fail to do something the law requires to be done; that is to say, with bad purpose either to disobey or to disregard the law.

<u>Metropolitan Dade County v. State Department of Environmental Protection</u>, 714 So.2d 512, 517 (Fla. 1st DCA 1998)[emphasis added]. In other words, a willful violation of a statute, rule or order is also one done with an intentional disregard of, or a plain indifference to, the applicable statute or regulation. <u>See, L. R. Willson & Sons, Inc. v. Donovan</u>, 685 F.2d 664, 667 n.1 (D.C. Cir. 1982).

Thus, the failure of each of the companies listed in Attachment A to allow access to its respective company records meets the standard for a "refusal to comply" and "willful violation" as contemplated by the Legislature when enacting Section 364.285, Florida Statutes.

"It is a common maxim, familiar to all minds, that 'ignorance of the law' will not excuse any person, either civilly or criminally." <u>Barlow v. United States</u>, 32 U.S. 404, 411 (1833); <u>see</u>, <u>Perez v. Marti</u>, 770 So.2d 284, 289 (Fla. 3rd DCA 2000) (ignorance of the law is never a defense). Moreover, in the context of these dockets, all competitive local exchange telecommunications companies, like the companies listed in Attachment A, are subject to the statutes published in the Florida Statutes. <u>See</u>, <u>Commercial Ventures</u>, Inc. v. Beard, 595 So.2d 47, 48 (Fla. 1992).

Further, the amount of the proposed penalty is consistent with penalties previously imposed by us upon other telecommunications companies that have failed to provide a response to a data request, thereby denying access to their records.

III. Decision

Therefore, we find it appropriate to impose a penalty in the amount of \$10,000 or cancel the respective certificate of each company listed in Attachment A for its apparent violation of Section 364.183(1), Florida Statutes, Access to Company Records.

This Order will become final and effective upon issuance of a Consummating Order, unless a person whose substantial interests are affected by this Commission's decision in a given docket files a protest that identifies with specificity the issues in dispute, in the form provided by Rule 28-106.201, Florida Administrative Code, within 21 days of the issuance of the Proposed Agency Action Order. As provided by Section 120.80(13)(b), Florida Statutes, any issues not in dispute shall be deemed stipulated. If any of the companies listed in Attachment A fails to timely file a protest in its respective docket and request a Section 120.57, Florida Statutes, hearing, the facts in that docket shall be deemed admitted, the right to a hearing waived, and the penalty shall be deemed assessed. If any of the companies listed in Attachment A fails to pay the penalty within fourteen (14) calendar days after the issuance of the Consummating Order, the company's CLEC certificate, as listed in Attachment A, shall be canceled. If a company's certificate is canceled in accordance with the this Order, that company shall be required to immediately cease and desist providing telecommunications services in Florida. A protest in one docket shall not prevent the action in a separate docket from becoming final. These dockets shall remain open.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that a penalty in the amount of \$10,000 be imposed to each company listed in Attachment A for its apparent violation of Section 364.183(1), Florida Statutes, Access to Company Records. It is further

ORDERED that the provisions of this Order, issued as proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business of the date set forth in the "Notice of Further Proceeding attached hereto. It is further

ORDERED that if any of the companies listed in Attachment A fails to timely file a protest in its respective docket and request a Section 120.57, Florida Statutes, hearing, the facts in that docket shall be deemed admitted, the right to a hearing waived, and the penalty shall be deemed assessed. It is further

ORDERED that a protest in one docket shall not prevent the action in a separate docket from becoming final. As provided by Section 120.80(13)(b), Florida Statutes, any issues not in dispute shall be deemed stipulated. It is further

ORDERED that if any of the companies listed in Attachment A fails to pay the penalty within fourteen (14) calendar days after the issuance of the Consummating Order, the company's CLEC certificate, as listed in Attachment A, shall be canceled. It is further

ORDERED that if a company's certificate is canceled in accordance with this Order, that company shall be required to immediately cease and desist providing telecommunications services in Florida. It is further

ORDERED that these dockets shall remain open.

Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, in the form provided by Rule 28-106.201, Florida Administrative Code. This petition must be received by the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on <u>October 15, 2008</u>.

In the absence of such a petition, this order shall become final and effective upon the issuance of a Consummating Order.

Any objection or protest filed in this/these docket(s) before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.
