NOTICE OF ENTRY OF ORDER (A) CONFIRMING FIRST AMENDED CHAPTER 11 PLAN OF LIQUIDATION, AND (B) FIXING DEADLINE FOR THE FILING OF CLAIMS RELATING TO REJECTED EXECUTORY CONTRACTS

TO ALL KNOWN CREDITORS AND PARTIES-IN-INTEREST:

PLEASE TAKE NOTICE that:

- American Network Exchange, Inc., the above-captioned Debtor and Debtor-in-Possession (the "Debtor"), filed a voluntary petition for relief under Chapter 11 of the United States Bankruptcy Code on May 5, 1999 (the "Petition Date") with the Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court").
- On November 6, 2008, the Bankruptcy Court issued an order (the "Confirmation Order") confirming the Debtor's First Amended Plan of Liquidation dated July 29, 2008 (the "Plan").
- Copies of the Confirmation Order, the Plan, and all pleadings filed, and orders entered, in the Debtor's Chapter 11 case may be examined and inspected by interested parties at the Bankruptcy Court, The Alexander Hamilton Customs House, One Bowling Green, New York, New York 10004, during regular business hours and are publicly available online *in electronic format* at the Bankruptcy Court's general web site address at www.nvsb.uscourts.gov.
- Rejection of Executory Contracts.** If the rejection by the Debtor of an unexpired contract or lease pursuant to the Plan results in a claim, then such claim shall be forever barred and shall not be enforceable against the Debtor or its property unless a proof of claim is filed with the Clerk of the Bankruptcy Court, 5th floor, United States Bankruptcy Court, Southern District of New York, Alexander Hamilton Customs House, 1 Bowling Green, New York, New York 10004 and served upon counsel to the Debtor at the address indicated below so that it is received on or before December 1, 2008.

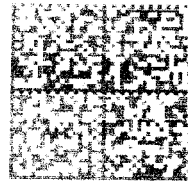
