One purpose of the workshop is to present and discuss the results of the Florida Renewable Energy Potential Assessment conducted by Navigant Consulting, Inc. The study assesses the current and future availability and cost of renewable energy resources in Florida. Funding is provided by the Lawrence Berkeley National Laboratory through a grant from the U.S. Department of Energy. The Florida Public Service Commission (FPSC) and the Governor's Energy Office have provided oversight and guidance to Navigant on the conduct of the assessment. Section 366.92, F.S., requires the FPSC to submit a draft Renewable Portfolio Standard (RPS) rule to the Legislature by February 1, 2009 for ratification. The proposed renewables assessment would be used by the FPSC as a source of information and data in developing the RPS rule. Also, the FPSC staff will present information and data requested by Commissioners at the October 14, 2008 agenda conference.
