Dr. Bane,

I reviewed the below request for oral modification sent to you yesterday and unfortunately it does not correct the problem. The reference should be to Schedule 4, not 4A. The Schedule 4 should not be renamed. The request should read as follows:

Staff requests approval to make an oral modification to the recommendation paragraph of Issue 18 for the above-referenced item. Specifically, on Page 35, the first sentence of the recommendation paragraph should read:

"The water rates should be reduced as shown on Schedule Nos. ~~4-A~~ to remove \$39,678 of water rate case expense, grossed-up for RAFs, which is being amortized over a four-year period."

On the same page, a corresponding adjustment should also be made in the first paragraph of the last sentence of the staff's analysis. The specific type and strike modification is as follows:

"The decreased revenue will result in the rate reduction recommended by staff on Schedule No. ~~4-A.~~"

The Statutory time frame to process this case has been waived by Wedgefield through the December 2, 2008, Agenda Conference. This requested modification has no other effect on Staff's recommendation including revenue requirement
