### PETITION FOR RATE INCREASE BY TAMPA ELECTRIC COMPANY.

NOTICE IS HEREBY GIVEN that a hearing will be held before the Florida Public Service Commission in the above docket regarding the petition of Tampa Electric Company (TECO) for a rate increase, at the following time and place:

January 21, 27, 28, 29, and 30, 2009, have also been reserved for continuation of the hearing if needed. The starting time of the next day's session will be announced at the conclusion of the prior day. The hearing may be adjourned early if all testimony is concluded.

#### PURPOSE AND PROCEDURE

The purpose of this hearing will be for the Commission to consider the application of Tampa Electric Company for increased rates, and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

DOCUMENT NUMBER-DATE

This proceeding shall: (1) allow TECO to present evidence and testimony in support of its petition for a rate increase; (2) permit any intervenors to present testimony and exhibits concerning this matter; (3) permit members of the public who are not parties the opportunity to present testimony concerning this matter; and (4) allow for such other purposes as the Commission may deem appropriate.

#### JURISDICTION

This Commission is vested with jurisdiction over the subject matter by the provisions of Chapter 367, Florida Statutes. This hearing will be governed by said Chapter as well as Chapter 120, Florida Statutes, and Chapters 25-9, 25-22, 25-30, and 28-106, Florida Administrative Code.

### APPLICABLE STATUTES AND RULES

Sections 367.081, 367.0816, 367.082, 367.091 and 367.101, Florida Statutes, and any other relevant sections of Chapter 367, Florida Statutes, are applicable to this proceeding, as well as Chapter 120, Florida Statutes, and Rules 25-9, 25-22, 25-30, and 28-106, Florida Administrative Code.

Members of the public who are not parties to this proceeding will have an opportunity to present testimony regarding TECO's petition for a rate increase. All members of the public who wish to offer testimony should be present at the beginning of the hearing, 9:30 a.m., Tuesday, January 20, 2009. All witnesses will be sworn in and will be subject to cross-examination at the conclusion of their testimony. By providing public testimony, a person does not become a party to the proceeding. Anyone wishing to become a party to this need determination proceeding should file an appropriate petition pursuant to Rule 25-22.039, F.A.C., with the Office of the Commission Clerk at the address listed below. Copies of the petition should be sent by mail to all parties. Those wishing to intervene in these proceedings, unless appearing on their own behalf, must be represented by an attorney or other person who can be determined to be a qualified representative pursuant to Chapter 120, F.S., and Rule 28-106.106, F.A.C. Petitions for leave to intervene must be filed at least five (5) days before the final hearing, must conform with Rule 28-106.201(2), F.A.C., and must include allegations sufficient to demonstrate that the intervenor is entitled to participate in the proceeding as a matter of constitutional or statutory right or pursuant to Commission rule, or that the substantial interests of the intervenor are subject to determination or will be affected through the hearing.
