- 3. I am an attorney, admitted to the practice of law in the State of Oklahoma. Formerly, I held the position of Assistant General Counsel to the Oklahoma Corporation Commission. I have practiced extensively before the Oklahoma Corporation Commission in matters relating to the regulation of utilities. Representing both gas and electric utilities, I have made appearances and participated in numerous regulatory proceedings. Such proceedings include general rate cases and earnings reviews, as well as proceedings involving, among other subjects, rate design, rate application, depreciation rates, affiliate transactions, integrated

resource planning, conservation programs, incentive rate plans, franchise or service territory rights, and pole attachments.
