By copy of this letter, we are formally objecting to the "Notice of Application for an Extension of Service Area" as filed by Aqua Utilities Florida, Inc. under Docket 080540.

We are a non-profit utility that provides bulk water to Aqua Utilities; and, therefore, objecting for reasons as follows:

1) Expansion into our existing service area. 2) No notification received of intent to expand. We were notified by an existing customer who received notice. 3) Bylaws that prohibit expansion of additional bulk water sales.

I have been in contact with Carl Smith, Aqua Utilities regarding this extension request. It is my understanding from Mr. Smith the proposed service area will be redefined to only include their existing service area in Holiday Haven. Once this has been submitted to our satisfaction, we will revoke our objection.
