# AMENDMENT NO. 2 TO THE INTERCONNECTION, COLLOCATIONAND RESALE AGREEMENT BETWEEN NUVOX COMMUNICATIONS AND EMBARQ- FLORIDA, INCORPORATED

This Amendment is made January 5, 2008, by and between NuVox Communications, Inc. ("CLEC") and Embarq – Florida, Incorporated ("Embarq"), a Florida corporation.
