





CUSTOMER NOTICE

ISSUED: JANUARY 20, 2009

On February 29, 2008, Miles Grant Water and Sewer Company (the "Utility"), completed its application to the Florida Public Service Commission (the "Commission") for increased water and wastewater service rates, in which it requested a permanent rate increase of 76.55% for water service and 87.98% for wastewater service.

By Proposed Agency Action Order No. PSC-08-0812-PAA-WS ("PAA Order"), issued December 16, 2008, the Commission approved a rate increase of 37.23% for water service and 72.03% for wastewater service. In addition, the Commission approved revised miscellaneous service charges. These rates and charges were designed to allow the Utility the opportunity to recover its reasonable and prudent costs for providing service, and a reasonable rate of return on its investment in facilities necessary to provide such water and wastewater service. The PAA Order was not protested within the protest period, and became final by Order No. PSC-09-0028-CO-WS, issued January 13, 2009.

The increased rates and charges are effective for service on or after January 25, 2009.

The rates prior to filing, the Commission-approved water and wastewater, and approved revised miscellaneous service charges are attached to this customer notice.

This notice was prepared by the Utility and approved by the Commission Staff for distribution by the Utility to its customers.
