Dear Mr. Friedman:

By this letter, the Commission staff requests that Labrador Utilities, Inc. (Labrador or Utility) provide responses to the following data requests.

1. Please refer to Schedule E-2, page 3, and the supporting Schedule E-14, pp. 16-20. Data for 2" irrigation water customers is shown on these pages, indicating that 24 bills were rendered during the test year.
 - A) Please provide the names (customers of record) of each irrigation customer billed during the test year.
 - B) There is no corresponding consumption indicated for these customers. Was there consumption associated with any of these bills that was not reflected on Schedules E-2 and E-14?
 - C) If the response to (b) is affirmative, please revise the appropriate Schedules E-2 and E-14.
 - D) If the response to (b) is negative, when was consumption last billed to a 2" irrigation customer?
