3	staff, we move to Item 9. Staff, you're recognized.				
4	MS. ISLER: Item 9 is staff's recommendation				
5	to cancel three companies' IXC registrations due to an				
6	assignment for the benefit of creditors' proceeding,				
7	which is, I've been told is like a bankruptcy under the				
8	Florida Statutes, and write off the unpaid regulatory				
9	assessment fees.				
10	CHAIRMAN CARTER: Commissioner Skop.				
11	COMMISSIONER SKOP: Thank you, Mr. Chairman.				
12	Again, I had a similar concern on this in				
13	terms of the diligence of the Commission in pursuing				
14	such fees that may be outstanding. While staff is				
15	correct, essentially assignment for benefit of the

17	difference is the automatic stay under bankruptcy law				
18	does not attach. And there is a provision where if a				
19	proof of claim is filed, that a government, governmental				
20	agency pursuant to statute has the ability to go after				
21	the assignee for the claim.				
22	So, again, I don't know, I didn't get a chance				
23	to research the points of law on that. But, again,				
24	without filing the proof of claim, and there's a 120-day				
25	hard bar on that, we're out of luck. So, again, if we

1 have notification of the pending petition in the court 2 to make that assignment, it might be, might behoove the 3 Commission to, to make that filing just for the sake of doing it.
